### **CANDIDATES FOR THE L.F.A. BOARD OF DIRECTORS – 2014-2015**

Voting for the 2014/2015 LFA Board of Directors will commence on **Tuesday**, **April 22**, **2014** and close on **Monday**, **April 28**, **2014**, at **3:30 p.m**.

### **ALISON CURTIS, LIBRARY**

I am the Coordinator of Collection Development at the Library, and have worked at Langara as a librarian for twelve years. I have served one term on the LFA Board, and over the past year have appreciated the opportunity to learn about the work of the Board, the work of our stewards, and the many day-to-day issues involved in running a union. I feel it's useful to have at least one non-instructional faculty member on the Board, to ensure that issues from those areas have representation.

One area where I feel the Board could improve is in opening better communication channels, to inform and engage members in discussions about local union-related issues. Until I joined the Board I had no idea how effective and essential the work of our stewards is in defending our Collective Agreement rights, and I would like to see that information more broadly shared and appreciated. I also think we need a forum for raising awareness about issues that affect our sector and the union movement generally. If elected for another term, areas I would like to focus on include developing an LFA newsletter, improving the LFA website so that it can be more easily used as communication tool, and serving on the LFA Bargaining Team.

### **BRADLEY HUGHES, PHYSICS**

I would like to be part of the LFA executive to do two things. I would like to organize a regular LFA newsletter to report to the members on the decisions made by your executive and on other developments on campus that will effect us.

I would also like to find a way to get full-time work for our members who are stuck working part-time. Currently we have some of the best regularization language amongst the member unions of the Federation of Post Secondary Educators (FPSE). As a consequence, there is a clear path from temporary work to regular work. However, there is no mechanism to create full-time work for our part-time members. Instead they are left waiting, frequently for years, for a colleague to quit or retire. If I am elected to our executive I will try to make it a priority of our union to find a way to have more sections created to allow part-time members to become full-time.

I have been an instructor in the department of Physics & Astronomy at Langara for 10 years. In that time I have been a representative for our union to the FPSE non-regular committee, served on the hiring and evaluation committee in my department and been an LFA representative to the evaluation committee in another. I also help with the International Socialists club on campus (www.socialist.ca) while I was a graduate student at SFU, I was a department steward for the Teaching Support Staff Union that represents Teaching Assistants and Sessional Instructors. I also served two terms on the executive of that union as Chief Steward. I would like a chance to bring that experience to the executive of our union.

# **CHERYL MCKEEMAN, MATHEMATICS & STATISTICS**

Thank you for nominating me to represent you on the LFA Board for 2014-2015. My personal skill is contract maintenance: ensuring that your rights as a faculty member are respected. ### INDIRA-NATASHA PRAHST, DEPARTMENT CHAIR OF SOCIOLOGY & ANTHROPOLOGY

One forum resulted in a CBC documentary featuring Langara students tackling some of the issues. This documentary brought Langara into a national spotlight. I was successful in applying for Social Science and Humanities research grants to research and engage various academic and community partners on the subject of these forums: safety, violence and gangs and education. Through these opportunities and engagements, I have garnered extensive experience and knowledge of how Langara functions as an institution, in both its successes and vulnerabilities. I am confident, energetic and enthusiastic at the prospect of being able to share my ideas and experience with my fellow LFA members from a proactive lens. Therefore, I am humbly asking for your support.

Some of the issues I wish to bring forward are:

- Creating diverse spaces for the LFA Board and its members to engage on issues impacting Langara and to solicit more support, participation and commitment from its members.
- Continuing the LFA's vigilance in protecting and in enhancing our role in Federation of Post-Secondary Educators (FPSE) and in shielding the interests of post-secondary education. As such, I will focus on developing strategies to contest changes threatening the structure and values of education in the public sector.

### PETER BABIAK, ENGLISH

I have been teaching in the English Department at Langara since 2002, when I began making the gradual transition from teaching at UBC. I am committed to the collegial faculty culture I found here at Langara and I am

committed to serving my colleagues here. To this end, I have been a member of the LFA board since 2012 and was on the LFA bargaining team during the last round of negotiations in early 2013. Learning about the LFA's crucial work in advocating for faculty concerns has been a steep learning curve for me because I am before all else a teacher but I am devoted to helping my fellow faculty members as best I can.

Prior to working at Langara, I taught at UBC as a "sessional" lecturer from 1996 to 2002 and I was on the team that succeeded, with the help of CUPE and the UBC Faculty Association, in lifting the unofficial policy of releasing contract faculty from their employment after a three year period. In 2001 I was academic coordinator of

the Humanities Storefront, a grassroots education program in Vancouver's Downtown Eastside and between 2002-2006 I was Academic Director of the Faculty of Arts Humanities 101 Community Programs, which offers a series of barrier-free education to economically marginalised students from around Vancouver. I have published academic articles on Canadian Literature, Postcolonial Literature and Theory, and the Rhetoric of Global Finance Capital and I am Features Editor at Subterrain Magazine, a literary-cultural quarterly in Vancouver where I regularly write essays on cultural and literary matters.

### SAL ALBANESE, SOCIOLOGY

I ask for members support to join the Langara Faculty Association Board because I believe that I can\_contribute in a variety of ways to mobilize faculty, students and others in the educational community to fight for the preservation of our working conditions. I have previously served one term as a Board member. The pressing issues at this time are many and include salary levels and fear of job loss. There are murmurs everywhere that our profession and its values are under assault but at the same time there are those who would try to sever the LFA's ties with other postsecondary educators, both provincially and nationally. I believe we need to work for greater unity of purpose to push back against attacks on collective bargaining rights and shared governance, the chiseling away at the benefits of both full-time and part-time faculty, government cutbacks and the consequent erosion of income scales and students ability to pay for an education. To meet these challenges the LFA will need new blood and new ideas to mobilize and organize our collective efforts to stand up for our working conditions, our rights, and our profession.

### If elected, I intend to:

- Promote a "members-at-large" review of the LFA's internal strategic planning process
- Improve lines of communication between the Board and the membership
- Reaffirm the values of the LFA as both a professional association and a union
- Enhance the LFA's participation in our provincial body, FPSE
- Seek to revive activism among members
- Raise our public profile through public statements on issues of major significance such as assaults on academic freedom

#### STEPHEN PHILLIPS, POLITICAL SCIENCE

I have taught political science at Langara for the past twenty years. In that time I served as chair of the non-regular faculty committee, co-chair of the social committee, and member (in 2002-2003) of the LFA Board. I later served on the Transportation Committee in which role I helped to bring the Employer Pass Program (EPP) to Langara. When TransLink announced plans last year to axe the EPP, I initiated a petition campaign to save it. Alas, it was not successful! More recently I have been working to bring to the attention of colleagues the vital importance of the LFA's remaining a member of the Federation of Post-Secondary Educators (FPSE).

I am seeking to return to the Board for the same reason I ran more than a decade ago: the need for improved communication and transparency within the LFA. While we have been fortunate to have had on the Board exceedingly skilled, hard-working representatives, there continues in my view to be too little communication between Board and membership and too little effort to engage wider participation. Case in point: many LFA members had never even heard of FPSE, an organization to which we've been affiliated for the past 25 years, until the issue was broached at last year's AGM.

It is clear that changes are afoot at the College, and elsewhere in the post-secondary education sector, that could profoundly affect our working conditions and the very nature of public education. A new management cadre is now in place at Langara; meanwhile our provincial government continues to de-fund post-secondary education while forcing colleges to rely more heavily on foreign students to finance their operations. If we are to formulate thoughtful and effective responses to these and other challenges, the Board needs to tap into the knowledge and wisdom of its members. That begins with improved communication flowing both ways between the Board and the membership at large.

At the same time the LFA needs to play a more energetic role in FPSE to advance our collective interests as educators and to defend the essential principles of public education.

To begin to address these concerns, I propose we do the following:

- produce a newsletter at regular intervals (featuring, for example, reports from LFA reps. on FPSE committees along with news and commentary by members at large);
- post important, timely information on the LFA website and make greater use of the LFA listserve (e.g., to inform members every year about LFA committees and to encourage interested members to get involved);
- hold general meetings more often to exchange information and ideas between the Board and the membership;
- amend our Bylaws so as to conduct annual LFA elections *before* the end of spring term classes when most faculty are on campus; among other things this would make it feasible to hold election forums at which members could actually meet and question the candidates
